

## Specific terms for any mode of transport

Incoterms	Seller's liability	Buyer's liability
<b>EXW</b> Ex Works	He makes the goods available at its plant or warehouse. He is not responsible for loading onto the means of transport, insurance or transport.	He assumes all risks and costs from the moment the goods are made available to the seller.
<b>FCA</b> Free Carrier	He delivers the goods to the carrier appointed by the buyer at an agreed place. If foreseen, he clears the goods for export.	He bears the risks and costs from the moment the goods are handed over to the carrier.
<b>CPT</b> Carriage Paid To	He pays for the carriage to the agreed place of destination, but the risk passes to the buyer upon delivery to the first carrier.	He assumes the risk from the moment of delivery to the first carrier.
<b>CIP</b> Carriage and Insurance Paid To	As for the CPT, but in addition he must provide insurance to cover the buyer's risk during transport.	He assumes the risk from the moment of delivery to the first carrier, with insurance cover provided by the seller.
<b>DAP</b> Delivered At Place	He delivers the goods to the purchaser at an agreed place. His responsibility ends before unloading.	He bears the risks and costs of unloading, import customs formalities and related charges.
<b>DPU</b> Delivered at Place Unloaded	He delivers the customs-cleared goods, unloaded from the means of transport, to the agreed place. Any export customs clearance is at your expense.	He assumes the risks and costs from unloading to the agreed place.
<b>DDP</b> Delivered Duty Paid	He is responsible for all costs and risks until delivery of the goods, cleared through customs, at the agreed place.	He assumes the risks and costs only once the goods have been delivered.

## Specific terms for maritime and inland waterway transport

<b>Incoterms</b>	<b>Seller's liability</b>	<b>Buyer's liability</b>
<p><b>FAS</b> Free Alongside Ship</p>	<p>He delivers the goods along the ship's edge at the agreed port of embarkation.</p>	<p>He assumes the risks and costs from the moment the goods are placed alongside the ship.</p>
<p><b>FOB</b> Free On Board</p>	<p>He delivers the goods on board the ship at the agreed port of embarkation.</p>	<p>He assumes the risks and costs from the moment the goods pass the ship's rail.</p>
<p><b>CFR</b> Cost and Freight</p>	<p>He pays the freight to the port of destination, but the risk passes to the buyer once the goods are loaded on board the ship.</p>	<p>He assumes the risks from the delivery of the goods on board the ship.</p>
<p><b>CIF</b> Cost, Insurance and Freight</p>	<p>As with CFR, but he must also provide marine insurance to cover the buyer's risk.</p>	<p>He assumes the risks from the delivery of the goods on board the ship, with the insurance cover provided by the seller.</p>
